- **Scrutiny of returns [Section 61 of the Central Goods and Services Tax Act, 2017]**- Where Competent Authority passed *ex parte* assessment order dated 7-2-2020 on assessee, since impugned order of assessment had been passed on 7-2-2020, whereas personal hearing

CLASSIFICATION OF GOODS

- **Iron Tubular Trevis [Heading No. 7306]** - Product Iron Tubular Trevis falls under Heading No. 7306, Entry No. 220 of Schedule III of Notification No. 1/2017-Integrated Tax (Rate), dated 28-6-2017, and attracts 18 per cent rate of tax - *S.K.M.L. Industries*, In re (AAR - AP) **446**
- **Laban [Heading No. 0403]** - Where applicant manufactures a product 'Laban' and its main ingredients are curd, water and spices, said product is classifiable as Lassi at HSN 0403 90 and is exempt from GST - *Sampoorna Dairy and Agrotech LLP*, In re (AAR - Guj.) **443**

CLASSIFICATION OF SERVICES

- **Health care services [Heading No. 9993 - Human health and social care services]** - Where applicant is a hospital and it is offering a package to inpatients covering treatment including all required medicines and other supplies for a consolidated amount that is prefixed, supply of medicines, implants and other items to inpatients is a composite supply where principal supply is health care services falling under SAC 999311 which is exempted - *Malankara Orthodox Syrian Church Medical Mission Hospital*, In re (AAR - Ker.) **450**
- Where applicant is a hospital and it is offering a package to inpatients covering treatment for a consolidated amount that is prefixed but that package does not include medicines,

implants and other supplies which will be separately billed according to type, brand and quantity of items as chosen by inpatients, health care services supplied by applicant is exempted as per entry at Sl. No. 74 of Notification No. 12/2017 - Central Tax (Rate), dated 28-6-2017 - *Malankara Orthodox Syrian Church Medical Mission Hospital*, In re (AAR - Ker.) **450**

- Where applicant is a hospital and it supplies medicines and other items to patients undergoing treatment as outpatients in different situations, services provided by applicant clearly fall within scope of health care services and are exempted from GST - *Malankara Orthodox Syrian Church Medical Mission Hospital*, In re (AAR - Ker.) **450**
- **Hostel facility [SAC 999293 - Commercial training and coaching services]** - Where appellant, an institute, is imparting coaching to students to facilitate them to obtain qualification such as Chartered Accountant and Cost Accountant, etc. and it offers hostel facility to its students at a rate of less than Rs. 200 per day per person including food and at a monthly rate of maximum Rs. 6000, coaching/training provided by appellant to its students along with hostel facility qualifies to be categorised as a composite supply and entire supply is to be treated as falling under SAC 9992-999293 (Commercial training and coaching services being principal supply) and hostel fee will be liable to GST at rate applicable for principal supply - *Logic Management Training Institutes (P) Ltd.*, In re (AAAR - Ker.) **392**
- **Imparting coaching to students to facilitate them to obtain qualification such as Chartered Accountant [Heading No. 9992 - Services provided by an educational institution to its students]** - Where appellant, an institute, is imparting coaching to students to facilitate them to obtain qualification such as Chartered Accountant, Cost Accountant, etc., appellant does not qualify to be categorised as educational institution and, therefore, services provided by it are not exempted from GST - *Logic Management Training Institutes (P) Ltd.*, In re (AAAR - Ker.) **392**
- **[SAC 999293 - Commercial training and coaching services]** - Where appellant, an institute, is imparting coaching to students to facilitate them to obtain qualification such as Chartered Accountant, Cost Accountant, etc., services provided by appellant fall under SAC 9992-999293 - Commercial training and coaching services - *Logic Management Training Institutes (P) Ltd.*, In re (AAAR - Ker.) **392**
- **Job work of pharmaceutical Drugs [Heading No. 9988 - Manufacturing services on physical inputs (goods) owned by others]** - Where applicant provides Job work services on Diphenylmethoxy N and N - Diethylaminethanol HCl (Job work of pharmaceutical Drugs), subject activity merits to be covered at entry (id) of Heading 9988 at Sl. No. 26 of Notification No. 11/2017-Central Tax (Rate), dated 28-6-2017 - *Romano Drugs (P) Ltd.*, In re (AAR - Guj.) **441**
- **Selling textbooks [SAC 999293 - Commercial training and coaching services]** - Where appellant, an institute, is imparting coaching to students to facilitate them to obtain qualification such as Chartered Accountant and Cost Accountant, etc. and it sells text books to its students, coaching/training provided by appellant to its students along with sale of books to students qualifies to be categorised as a composite supply and entire supply is to be treated as falling under SAC 9992-999293 (Commercial training and coaching services being principal supply) and sale of textbooks to students will be liable to GST at rate applicable for principal supply - *Logic Management Training Institutes (P) Ltd.*, In re (AAAR - Ker.) **392**

DEMANDS AND RECOVERY

- **Provisional attachment [Section 83 of the Central Goods and Services Tax Act, 2017]** - Where pursuant to investigation, on suppliers of petitioner, bank accounts of petitioner were attached, however, no show cause notice under section 74 was issued to petitioner, it could not be said that on date of issuing attachment order, any proceedings were pending

against petitioner; hence provisional order of attachment was to be lifted - *Sterne India (P) Ltd. v. Union of India* (Kar.) **356**

- Where no proceedings under section 62 or 63 or 64 or 67 or 73 or 74 are pending, concerned authority cannot invoke power conferred by section 83 - *S.S. Offshore (P) Ltd. v. Union of India* (Bom.) **383**
- Where Competent Authority provisionally attached bank account of assessee, assessee was to be directed to file an objection before Competent Authority, who shall pass a reasoned order in terms of section 83 and rule 159(5) and (6) - *Shri Radha Raman Alloys (P.) Ltd. v. Union of India* (Orissa) **387**

INPUT TAX CREDIT

- **Eligibility and conditions for taking credit [Section 16 of the Central Goods and Services Tax Act, 2017]** - Where applicant has availed input tax credit against receipt of services from 'G', applicant is not entitled for input tax credit claimed by it against invoices raised by 'G', pertaining to period Jan, 2020, Feb, 2020 and March, 2020 for which supplier has furnished Form GSTR-1 and Form GSTR-3B in November, 2020 - *Eastern Coalfields Ltd., In re* (AAR - West Bengal) **422**

LEVY AND COLLECTION OF TAX [SECTION 9 OF THE CENTRAL GOODS AND SERVICES TAX ACT, 2017]

- Where applicant is a hospital and it is offering a package to inpatients covering treatment for a consolidated amount that is prefixed but that package does not include medicines, implants and other supplies which will be separately billed according to type, brand and quantity of items as chosen by inpatients, supply of medicines, etc. that are not included in package and which are separately billed shall attract GST - *Malankara Orthodox Syrian Church Medical Mission Hospital, In re* (AAR - Ker.) **450**
- Where applicant is a hospital and it is charging for treatments, medicines and other supplies separately according to type, brand and quantity of items as per choice of patients, supply of each of individual goods and/or services shall be individually liable to GST - *Malankara Orthodox Syrian Church Medical Mission Hospital, In re* (AAR - Ker.) **450**
- Where applicant is a hospital and it supplies medicines and allied items to outpatients based on prescription of their doctors for consumption at home and follow up, supply of medicines and allied items by pharmacy run by hospital can only be treated as an individual supply of medicines, etc. and is liable to GST - *Malankara Orthodox Syrian Church Medical Mission Hospital, In re* (AAR - Ker.) **450**

REFUND

- **Tax [Section 54 of the Central Goods and Services Tax Act, 2017]** - Provisions of paragraph 3.2 of Circular No. 135/05/2020-GST, dated 31-3-2020 providing that even though different tax rate may be attracted at different point of time, but refund of accumulated unutilized tax credit will not be available under section 54(3)(i) in cases where input and output supplies are same, would have to be ignored - *BMG Informatics (P.) SUPPLY

- **Composite supply [Section 2(30) of the Central Goods and Services Tax Act, 2017]** - Where applicant is a hospital and it is offering a package to inpatients covering treatment including all required medicines and other supplies for a consolidated amount that is prefixed, supply of medicines, etc. to inpatients is a composite supply - *Malankara Orthodox Syrian Church Medical Mission Hospital*, In re (AAR - Ker.) **450**
- **Scope of [Section 7 of the Central Goods and Services Tax Act, 2017]** - Where one 'S' vide lease deed dated 7-7-1993 allotted 15 acres of land on lease to applicant for a period of 99 years for purpose of setting up an industry and subsequent to allotment certain land allotted to applicant remained unutilized and in meantime one 'T' approached applicant for transfer of unutilized land for setting up of a gas plant and applicant vide Memorandum of Understanding dated 20-11-2020 agreed to transfer leasehold rights in land admeasuring 5 acres to 'T' for Rs. 15 crores, activity of agreeing to part with leasehold interest held by applicant in favour of 'T' was supply - *India Pistons Ltd.*, In re (AAR - Tamil Nadu) **433**
- **Taxable supply, value of [Section 15 of the Central Goods and Services Tax Act, 2017]** - Where appellatant, an institute, is imparting coaching to students to facilitate them to obtain qualification such as Chartered Accountant, Cost Accountant, etc. and it collects and transfers examination fees and other fees of recognized institutes or universities on behalf of students studying at its institute, if conditions prescribed for pure agent in rule 33 are satisfied in respect of amount collected as examination fees/other fees by appellatant from students enrolled with it, then such amount can be excluded from value of taxable supply - *Logic Management Training Institutes (P.) Ltd.*, In re (AAAR - Ker.) **392**
