■ Deemed to accrue or arise in India

- Royalties and fee for technical services - Where assessee, a China based company, sold telecom equipments *i.e.* mobile handsets to various customers in India, since supply of software embedded in telecom equipment enabled use of hardware sold, it resulted in a case of sale of copyrighted article and, thus, payment made towards supply of software was not taxable in India as royalty - CIT v. ZTE Corporation (Delhi) 252

INTEREST ON BORROWED CAPITAL

For the purpose of business - SLP granted against High Court's ruling that where assessee builder advanced borrowed amount to its sister concern for purpose of acquiring a portion of property in project proposed to be developed by its sister concern and said amount was not utilised for said project but it was used for some other project, assessee was not entitled for deduction of interest paid on borrowed amount - Embassy Development Corpn. v. Asstt. CIT (SC) 207

MINIMUM ALTERNATE TAX

Conditions precedent - Where in earlier year, assessee claimed excess depreciation and made a provision towards land development and in current year, these were written back/withdrawn, in computation of book profit under MAT provisions, downward adjustment would be allowed only if book profit of earlier year was increased by amounts credited to profit and loss account - V.G.P. Housing (P.) Ltd. v. Asstt. CIT (Mad.) 199

UNEXPLAINED MONEY

- Applicability of Where certain addition was made to assessee's income on basis of a chart recovered from search proceedings carried out in case of third party, since assessee was neither a searched party nor a party receiving notice under section 153C, evidentiary value of chart recovered could not be regarded as conclusive and, thus, impugned addition was to be set aside Pr. CIT v. Phonenix Datatech Services (P.) Ltd. (Delhi) 209
